1. The Foundation does not provide funds to be used for propaganda, lobbying activities or the election of public officials.
2. The Foundation does not participate in the establishment of or addition to endowments, or respond to mass appeal solicitations.
3. An applicant may request a grant by completing the attached Application for Support. The request may be accompanied by brochures or other additional materials about the applicant.
4. All grant application questions and statements should be answered by the applicant.
5. The subject of the grant must fall within the scope of the Foundation's mission statement.
6. Grants must be used strictly in accordance with the proposal and budget submitted to the Foundation. Any funds that are not expended must be returned to the Foundation.
7. The Foundation will not fund organizations that are not 501(c)(3) organizations. Applicants must attach a copy of 501(c)(3) exemption letter from the IRS.
8. All materials submitted to the Foundation become the property of the Foundation and will not be returned.
9. The receipt of a grant award is not guarantee of future awards.
10. The Foundation requires grant recipients to provide quarterly status updates to members of the grants committee. Typically, status updates may be provided by e-mail, but the committee might occasionally request an in-person meeting. These status updates enable the committee to understand how the grant recipient's project is progressing and give the grant recipient an opportunity to receive ongoing input from the committee.
11. In rare cases, where it becomes apparent that a recipient is not using the grant money for the purposes set forth in the grant application, the committee reserves the right to request that the grant money be refunded.
